Highlights of this exciting journey:



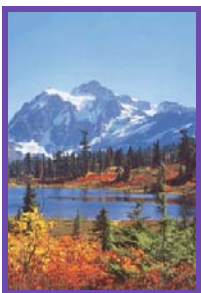
Eight nights at four locations, including a dinner by hosts,
